Hybrid Partnering

Partnering with schools implementing in-person consumption or grab-n-go to identify and serve eligible students that do not have access to transportation or ability to go in-person for meals



Home Delivery

Direct door-to-door deliveries. Families self enroll and custom software determines eligibility.

FUTURE OPPORTUNITIES AND GOALS

- Increase fresh food, fruit and vegetable availability to all areas.
 - Due to the distance of serviced areas from the meal preparation facilities of food vendors, the distribution of fresh food options is challenging.
 - Majority of meals served and consumed through home-delivery model are shelf-stable due to distribution limitations
- Diversify meal options for participants
- Create opportunities for local meal providers to serve as vendors in their own communities
