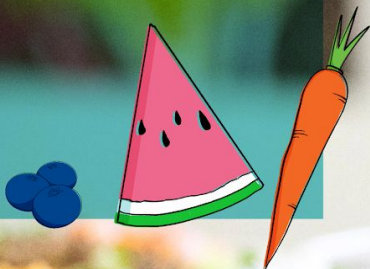

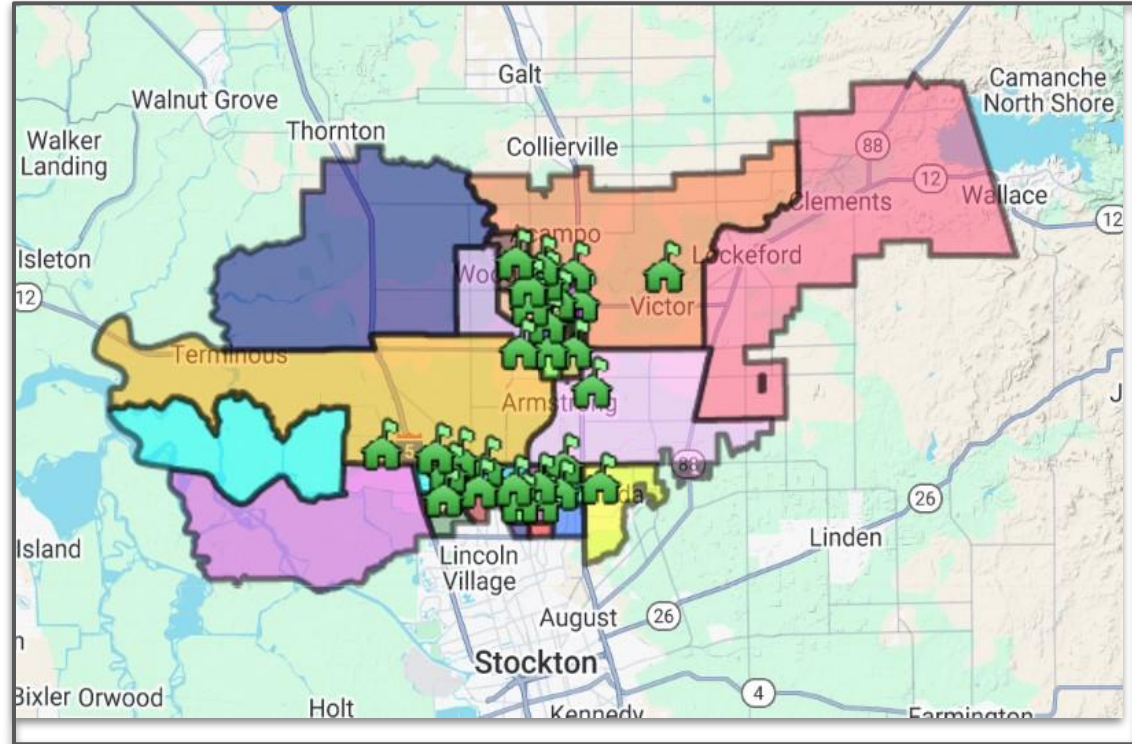

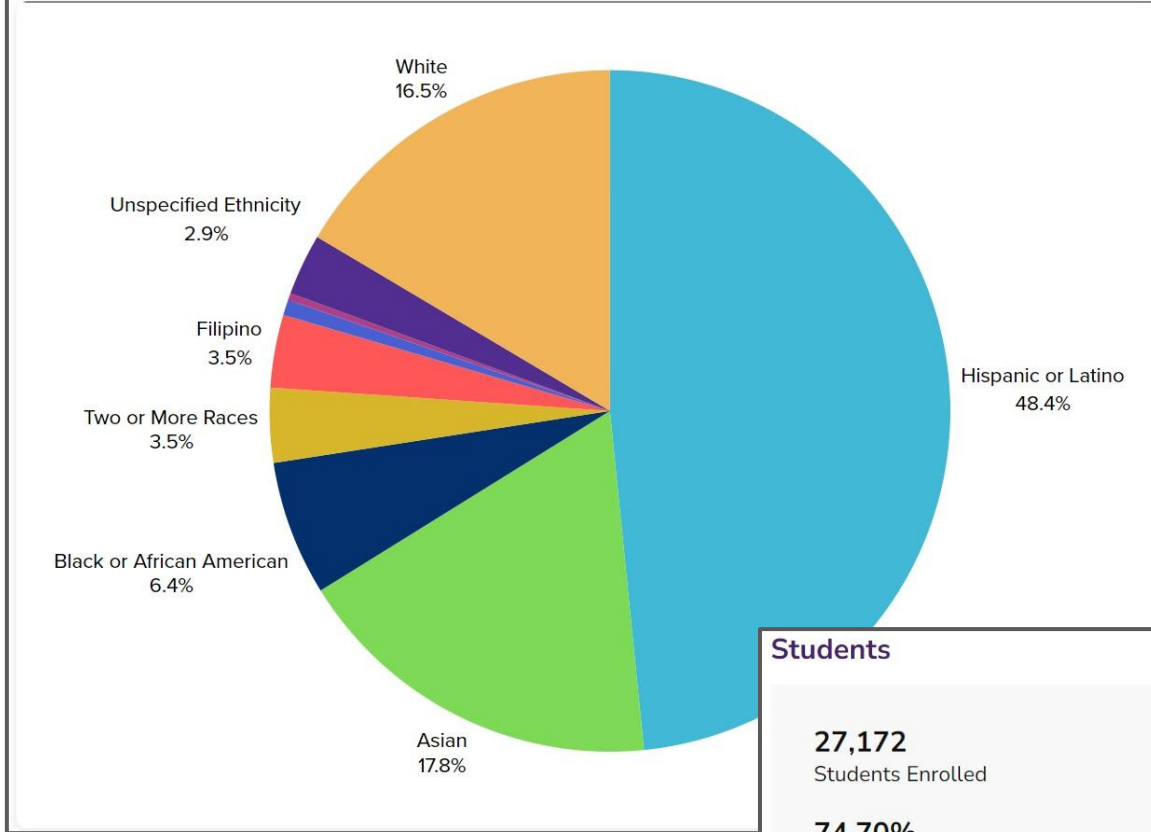
- **Lodi Unified School District (Lodi USD)** spans 350 square miles.
- **Cal EnviroScreen 4.0** ranks environmental vulnerability from 10% (suburban) to 95% (inner-city).
- **100% Community Eligibility Provision (CEP) District**



Lodi USD Demographics

- **San Joaquin County** has a 15.6% food insecurity rate, with 68% of families at or below 185% of the poverty line, affecting 32,690 children.
- **Ed-Data.org** reports Lodi USD has an ethnic diversity index of 53 and **72% free/reduced meal eligibility**.
- **48.8%** Hispanic/Latino students.
- Approximately **200 migrant students** are currently enrolled.

Integrity Plan

Digital Reservation System

- Guardian name, phone number (identifier), child's name & age, email (optional).
- Attestation statement:
 - I understand that my children are eligible to receive one breakfast and one lunch per calendar day and I agree to receive a Multiday Meal Box instead of daily meals.
 - My children will not receive any school meals from a Lodi Unified School District (LodiUSD) campus or other LodiUSD meal service program between the dates of Tuesday, July 9th through Thursday, July 18th.
- Timestamp activates on google form upon registration.
- Develops a live database of guardians picking up meals.

California Department of Education (CDE) - Guidance

Parent/Guardian Meal Pick Up

1. In accordance with 7 CFR 225.16(i)(2), approved sponsors may distribute meals to parents or guardians to take home to their children. Sponsors electing this option must have written documented procedures in place, to ensure that meals are only distributed to parents or guardians of eligible children and that duplicate meals are not distributed. **Procedures must be on file at the feeding site and be made available to the CDE upon request.**
2. **A parent/guardian is an individual that maintains a caregiver relationship between themselves and the child on the day of the meal service (SFSP 08-2024, SP 15-2024 Question 26).**
3. Individuals caring for groups of unrelated children **formally enrolled in care** are not considered guardians and cannot collect program meals on behalf of parents or guardians for children attending their childcare (SFSP-08-2024, SP 15-2024 Questions 26 and 27).

Unique Measures - Multi-Family Pick Up: leveraged “**Guardian for the Day**” guidance to eliminate traffic congestion & reduce wait times, while simultaneously increasing access to more families.

Troup County Schools-Community Background

Troup County, GA is a rural community located in west central GA; it is about 414 square miles and has approx. 70,000 people. All neighboring counties are rural with little to no industry found in those communities.

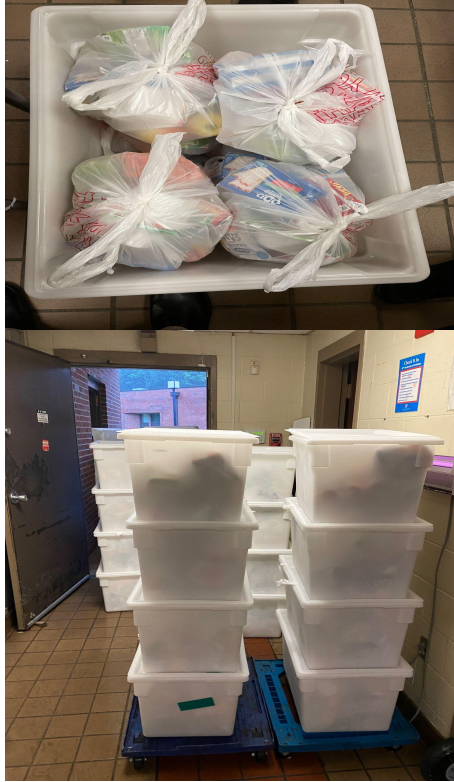
It is comprised of three towns: Hogansville, LaGrange, and West Point.

White=58%; Black=37%; Asian=2%; Multiracial=2%; Other=1%
Hispanic or Latino=5%

All schools in Troup County are 100% CEP.

Program Model - Mobile Distribution

- **Troup County Schools used a refrigerated truck to distribute meals via set routes due to lack of public transportation.**
- **7 breakfast and lunch meals distributed per child.**
- **Distribution sites included low income housing, libraries, churches, apartment complexes.**
- **Meals were distributed via three routes in different areas of the county.**
- **Two routes had 5 stops with distribution done on Monday.**
 - LaGrange-approx 500 student meals**
 - Hogansville-approx. 100 student meals**
- **One route had 3 stops with distribution done on Wednesday.**
 - West Point-approx. 200 student meals**

Integrity Plan - State Approval

- Speak with State Area Consultant prior to implementation for verbal approval. Then begin talking with community members.
- All sites must be USDA Area Eligible and submitted to Area Consultant: <https://www.fns.usda.gov/cn/area-eligibility>
- All sites must be located in a USDA Rural Designation and submitted to Area Consultant: <https://www.fns.usda.gov/sfsp/rural-designation>
- Mobile route showing stops must be approved by State Area Consultant and entered into State database prior to implementation.

Integrity Plan - Information Collection

- **Create a Master Distribution List on Google Sheets.**
- **Parents call in to our central office to register; it was sorted alphabetically by parent/guardian last name.**
- **This list is updated only by personnel at the central office; names were checked for duplication prior to being added.**
- **Information Collected: Parent/Guardian Name, Children's Names, Phone Number, Pick Up Location, Number of Meals**
- **Parent/child names checked off as meals were picked up**

Integrity Plan-Food Safety and Distribution

- **Temperature logs are required. Temperatures must be taken at each stop.**
- **Distribute menus to each family (State Requirement) so they can see what foods are to be eaten as one meal. Our meals are packed in 3 bags per student—frozen, cold, and milk.**
- **Reheating instructions given to each family (State Requirement).**
- **Ensure that any leftover food will not expire prior to the next delivery; use first in, first out.**

Integrity Plan - Mobile Distribution

- **Same staff used at all distribution sites.**
- **Relatively small community so many people know one another.**
- **Distribution timeframes are short—from 15 minutes to 45 minutes prior to moving to the next stop.**
- **Required to serve any eligible families that did not register; their names were added to the distribution list.**
- **No identification was required to be shown for meal pick up (per State guidance).**

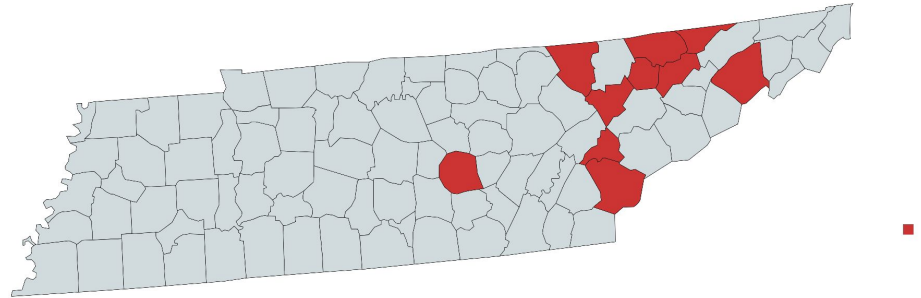

Program Model

- Served Multi-County Area
 - Served 10 counties in 2024.
 - As many as 15 counties in the summer.
- Non-Congregate AND Congregate Sites
- 2024 Sponsored 109 Sites with 18 of those sites Non-Congregate drive-thru, Grab N'Go sites

Program Model

- No Commercial Kitchen
 - Contracts with school food services or private vendors to provide summer meals at approved sites.
 - Congregate sites order the number of meals they need each day morning.
- Volunteers for Site Supervisors- Training provided for each site.
- Served as Sponsor
- Partnered with Schools as sites



Unique Integrity Measures

- Registration System- Call School to register
- Created Roster System- Last Name of family, then first name and age of each child picking up for during meal distribution.
- Letter to Parents- Letter given to all children at congregate sites.
- School Food Service Staff Distribute Meals
- School Staff Familiar with students and their families
- Children were registered for the school they normally attended.



Strategic Meal Distribution Times



- Distributed meals at the exact time at each Grab & Go site, example 11:00am-1:00pm
- This was to help prevent families from picking up at more than one distribution site.
- Families were directed to the site that they registered their children.

Car Tags

- Car Tags distributed during first distribution
- Tag included family's last name and number picking up for on tag
- Information compared to created roster
- Participant added to roster if not pre-registered and given tag.
- Car tags assisted in moving the cars through much quicker



Color Bag System

- Insulated Bags Provided by ETHRA at first meal distribution
- Bags added a visual to recognize registered participants.
- Added additional protection for maintaining food temps.
- Bags were color coded for each individual site.
- Parents brought bags back each week for the meal distributions.

Program Model & Community Background

Bossier Parish in Northern Louisiana

- 839 square miles (50 min. drive from top to bottom)
- Population 130,000 people
- Mix of urban, suburban & rural communities
- 33 schools with ~22,500 students

Non Congregate Program Model

- “Drive Thru” at 4 rural sites
 - North, south, east & central sites
- 1 day/week from 8:00-1:00
- 7 day shelf stable meal boxes (breakfast & lunch)
- 3 day shelf stable meal bags for congregate summer school kids
 - 4 school days/week in June
- RFP: Optimum Foods - everyone loved them!
- ~38,000 boxes distributed over 8 weeks = ~532,000 meals



Unique Integrity Measures



- Google form registration QR code advertised everywhere
- Mass text message to all BPSB parents

Unique Integrity Measures

- Google registration form creates a LIVE spreadsheet for all 4 sites to use “in real time”
 - Intended to enter in student names manually and mark the distribution date and site
 - We added columns G-V (in pink/purple) to the spreadsheet to track meal pick ups
 - Distribution dates
 - Location drop down box
 - If it was already filled out, this indicated a duplicate pick up
 - Congregate summer school students were coded **BLUE** to indicate **3 day bags**

- This worked, but proved to be challenging & slow

Unique Integrity Measures

- **What we learned:**

- It was problematic to get child's name if parent pick up form wasn't required
 - Noise, distance from vehicle to the check in tent, language & spelling challenges
- CTRL + F = search box to easily search
- FYI - names have to be EXACTLY the same
 - Matthew Brown vs. Matty Brown name provided = won't show up
- Can also search by parent name, address or phone number
- Weather (heat & rain) and power sources were problematic

- **Result:**

- We had to take forms and enter names into the spreadsheet AFTER distribution
- Still allowed us to have integrity, but time consuming
 - Could result in loss of revenue if duplicate meal boxes given out & not able to be claimed
- All forms kept for integrity/audit purposes

Unique Integrity Measures

- Adjustments made after our 1st week:
 - Technology team created a unique scan code for each child
 - Emails with scan code were sent out to each child with instructions to print & bring
 - We bought scanners & gathered chromebooks
 - At pick up, codes would be scanned & automatically recorded on Google sheet

Parent pick up form provided via email

- Paper copies available on site
- Only needed if child not present
- Scan code sheet could be signed & dated in lieu of pick up form
