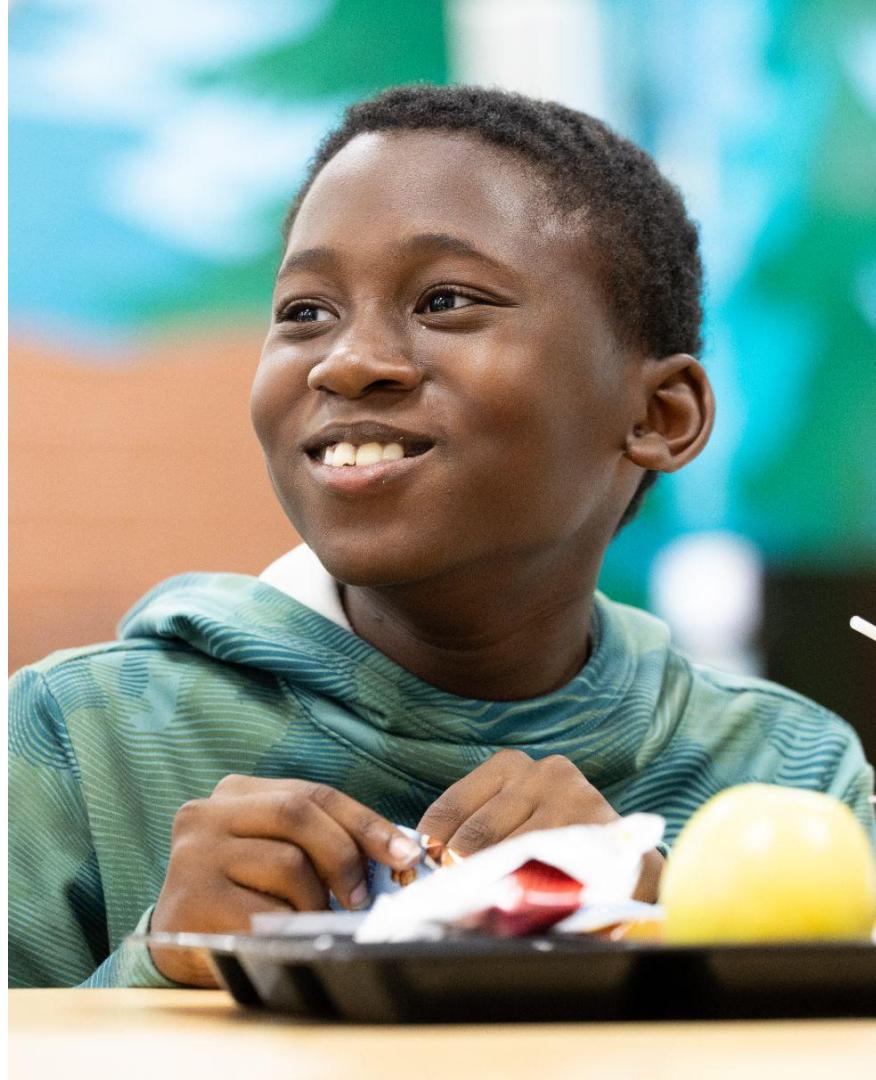



Overview of Recent SNAP Policy Updates

- Congressional Actions
 - H.R. 1
 - Federal Government Shutdown
- Administrative Actions
 - Data Sharing
 - Purchase Restrictions
- Looking Ahead at Priorities

H.R. 1 & SNAP

- Changes to the funding models for SNAP, including:
 - Increases the administrative cost share for state/local agencies to from 50 to 75% beginning this October; and
 - Establishes a first-ever cost-share for SNAP benefits of 0-15% based on the state's Payment Error Rate beginning next October.
- Changes to allowable deductions for SNAP benefit calculations, and limits how much benefits can increase in the future.
- Changes to eligibility for non-citizens.
- Expands existing SNAP work requirements.

Administrative Actions by the USDA-FNS

- **Data Sharing** - FNS has created a new national database of SNAP participants and are asking all states to provide household data to support its initiatives.
- **Food Restrictions** - 18 states have been approved for waivers with 5 going live this month. This will likely impact S-EBT benefits as well.
- **Program Integrity** - FNS continues to focus on fiscal responsibility and program integrity, including now for S-EBT.

Overview of Child Nutrition Policy Updates

 - Limited summer nutrition memoranda and guidance
 - Other administrative actions: public charge & immigration enforcement
- Looking Ahead

How H.R. 1 Will Impact Child Nutrition Programs

- SNAP and Medicaid participation data is used for:
 - Direct certification for school meals
 - Streamlined certification for Summer EBT
 - Community Eligibility Provision (CEP) eligibility & reimbursement
- Declining direct/streamlined certification → more application burden on families & schools/agencies, fewer kids certified
- School meals eligibility rates determine summer & afterschool area eligibility
- Summer EBT benefit levels constrained by Thrifty Food Plan
- State budget pressure may impact child nutrition programs

Public Charge & Immigration Enforcement

- Public Charge:
 - “Public charge” guidance formalized under Biden administration following challenges to proposals under first Trump administration
 - Dept. of Homeland Security issued a proposal in late 2025 to rescind the current public charge rules
 - The proposal said new guidance would be forthcoming
 - Current public charge rules are in effect until a final rule takes effect
- This & other immigration enforcement actions create a significant “chilling effect” on program application submission & participation

Looking Ahead

- **Congress** - While SNAP and nutrition programs are funded through September, Congress still must pass another funding bill by the end of this month.
- **USDA** - We anticipate that FNS will soon post a new proposed rule to significantly reduce the application of Broad-Based Categorical Eligibility (BBCE). This would have ripple effects on school meal eligibility and S-EBT.
- **All** - Continuing to follow H.R. 1 implementation.
