Summer EBT provides **\$120 of extra grocery benefits** to children (like yours!) over the summer, when kids aren't getting the meals they usually eat at school. It is available to families who could use support buying food.

Most eligible children are automatically enrolled in Summer EBT, but some will need to apply.

## HOW TO CHECK OR UPDATE YOUR MAILING ADDRESS

This depends on the state, and it probably takes more than one line to detail it out because it might be the school or a state number.

## WHEN FUNDS ARE DELIVERED

Beginning [DATE], SEBT funds will be mailed out as applications are processed.

## IS THERE AN EXPIRATION DATE?

Yes, funds expire 122 days (about 4 months) after they are issued.

### How do I apply for Summer EBT?

Families can apply for Summer EBT **online** or with a paper application. **Contact your state Summer EBT office or school for help with paper applications.** Remember, this benefit is for families just like yours. Apply!

### Why do some kids get Summer EBT support automatically, while others need to apply?

Many eligible children are automatically enrolled in **Summer EBT** through other programs they already participate in. But here's the bottom line: If you don't receive the program automatically, and you have a child attending school, we recommend applying if you could use an extra \$120 to help with groceries over the summer.

You can quickly check your eligibility using the link on the front page. Students of any age who meet the income and school attendance requirements are eligible to apply. If some, but not all of your children attending school received **Summer EBT** automatically, or if your child received it in 2024 but not 2025, your child may be eligible but needs to apply.

### What information or instructions will I receive in the mail?

**Example: Keep an eye out for information about how to activate your Summer EBT card(s). Your Summer EBT benefit card will arrive in a separate envelope. Save all your Summer EBT paperwork from the state just to be safe!**

### What should I do if I have problems activating my card or have other questions?

**Include state-specific instructions on how to activate the card.** If you have other questions about your card or benefits, contact **[States]** customer support team. They are here to help.

### What other grocery or food support programs are available over the summer?

**Summer EBT** works alongside in-person Summer Meal programs to help make sure kids get nutritious food all year round.
