Current Waivers to Support Possible Schedule and Meal Service Models



Waivers



Nationwide Waivers Available for SY20-21

For NSLP (including SSO), SBP and CACFP:

- Congregate Meal Service
- Meal Service Time
- Parent/Guardian Meal Pick-Up
- Meal Pattern

For NSLP only:

• Offer Versus Serve (OVS) for High Schools

Nationwide Waivers Available for SY20-21

- Onsite Monitoring
 - School programs (including SSO): through June 30, 2021
 - CACFP: through September 30, 2021
 - SFSP: through September 30, 2021

Waivers NOT Available for SY20-21

- Nationwide Waivers for SFSP
 - Congregate Meal Service
 - Meal Service Time
 - Parent/Guardian Meal Pick-Up
 - o Meal Pattern
 - Area Eligibility
- Nationwide Enrichment Waiver for Afterschool Meals & Snacks
- FFVP Waivers

Planned & Unplanned Closures

- SFSP & SSO are available for <u>unanticipated</u> closures October-April
 - Planned distance learning or closures do *not* count as unanticipated closures
 - No waiver flexibilities for SFSP, even during unanticipated closures



A Potential Service Gap

- Some schools are delaying the start of the year
- Most summer meals waivers expire August 31st
- SSO may be an option until school starts

Options for Schools




Possible School Schedule Model

100% Distance Le	arning	All students learn remotely						
	Grade-Level Return	Younger students return to school while older students learn remotely, or vice versa						
Hybrid Learning	Targeted Return	Some students return to school while others continue distance learning						
	Alternating Schedule	Groups of students switch between in-person and distance learning						
100% In-Class Lea	arning	All students return to school						

Student Location & Schedule Model

Meal Service Options



Student Location & Schedule Model

100% Distance Learning All students are at home

Hybrid Learning Some students are remote and others are at school

100% In-Class Learning All students are at school

Meal Service Options

- Direct Home Delivery
- Delivery via Mobile or Bus Routes
- Walk-Up Distribution
- Drive-Thru Distribution
- Students take home meals on days they attend in-person class for the following distance learning days.
- Service Location:
 - Cafeteria service line
 - Kiosks halls or common areas
 - Classrooms
 - Hybrid
- Eating Location:
 - Cafeteria
 - Common areas (gym, etc.)
 - Classrooms
 - Outside


Program & Waiver Considerations

- Permitted for breakfast through SBP and lunch through NSLP for days when instruction is offered.
 - Usual counting, claiming, and charging is required.
- State agencies may require a plan so that students are charged correctly and do not receive meals at multiple sites.
 - Students may be limited to receiving meals at the school where they are enrolled.
- Permitted for breakfast through SBP and lunch through NSLP on days when instruction is offered.
 - Usual counting, claiming, and charging is required.
- Refer to state and local guidelines for group size, physical distancing, and safety recommendations.

Instructional Time & Attendance

- NSLP & SBP are only available on or for school days
 - Virtual learning days *do* count as school days
 - For fully four-day school week:
 - NSLP/SBP are not options on the "fifth day" without instruction
 - CACFP At-Risk is an option but requires enrichment activities
- How attendance will be factored is unclear

Options for Non-Profit Sponsors



Care for School-Aged Children of Essential Workers

- No SFSP option
- Work with schools for NSLP/SBP meals
- CACFP At-Risk Afterschool
 - \circ In eligible areas
 - Limited to one meal + one snack
- CACFP Outside School Hours Care
 - Limited to children 12 and under
 - Individual income eligibility determination required

For Other Non-Profit Sponsors

- CACFP At-Risk Afterschool
 - \circ In eligible areas
 - Limited to one meal + one snack
 - Provide enrichment check with your state agency



CARES Act – Opportunities to Support Nutrition Programs

Coronavirus Relief Fund

\$150 billion to state, territorial, and tribal governments and major localities to broadly cover costs associated with COVID-19 response.

Elementary and Secondary School Emergency Relief (ESSER) Fund

- \$13.2 billion to state education agencies (of which 90% must be sub-granted to local education agencies based on Title I funding) to cover costs associated with school functionality, including planning to provide school meals.
- Governor's Emergency Education Relief (GEER) Fund
 - \$3 billion to state governors for distribution to local education agencies or institutions of higher education to support school functionality.



CARES Act – State Allocations

Virginia

Allocated \$3 million in GEER funds to assist with unfunded costs of school-based meal programs.

North Carolina

• Appropriated \$75 million in Coronavirus Relief Funds for school nutrition services provided in response to COVID-19.

California

 Appropriated \$112.2 million in ESSER funds to provide additional reimbursements to schools for meals served from March through August 2020.



CARES Act – State Allocations

Kentucky

- Allocated \$30 million in GEER funds to broadly support needs of schools, including maintaining food service.
 - Note: allocation not limited to school meals.

Vermont

 Appropriated \$12 million in Coronavirus Relief Funds for summer meal sponsors to support continuation of meal delivery services in June, July and August 2020.



CARES Act – What Should You Do?

- In states where CARES Act funds <u>have</u> been specifically allocated for nutrition programs:
 - Ask your state agency about how to access these funds.
- In states where CARES Act funds <u>have not</u> been specifically allocated for nutrition programs:
 - Ask school district leadership about the potential to use ESSER funds for the school nutrition program.
 - Ask your state agency about plans to request an allocation of unspent funds for nutrition programs.
 - Advocate for state leadership to allocate funds specifically for nutrition programs.



FEMA Public Assistance Grants

- In response to COVID-19 disaster declaration, FEMA grants may be available to state and local government entities and nonprofits to reimburse qualifying work.
 - Qualifying work under FEMA policy includes purchase and distribution of food in response to COVID-19.
- FEMA grants generally cover 75% of the costs of qualifying work.
- Duplication of benefits prohibited: FEMA grants generally cannot cover costs of providing assistance if that assistance is available through another federal program.



Future Financial Assistance?

- GEER and ESSER Funds Refill
- State and Local Financial Aid
- FEED the Children Act (H.R. 6801)
 - Included in House-passed HEROES Act
- State-Based Aid

CEP supports students, families, and schools.



What is the Community Eligibility Provision (CEP)?

- Enables eligible schools to provide breakfast and lunch to all students at no cost to them
 - · Often heralded as the antidote to "school lunch shaming"
 - Students have equitable access to all meals reduced stigma
 - Decreased administrative burden
 - School nutrition fund *can* benefit tremendously
- CEP is a 4-year cycle
- Schools, or groups of schools, must have an "Identified Student Percentage" (ISP) of 40% to operate CEP

Identified Student Percentage (ISP)

Identified students are categorically-eligible for free school meals and identified through **direct certification**.

Students are identified by their participation (or a household member's participation) in:

- SNAP: Supplemental Nutrition Assistance Program
- **TANF**: Temporary Assistance for Needy Families
- **FDPIR**: Food Distribution Program on Indian Reservations
- Medicaid Free*

Children who are...

- in foster care,
- experiencing homelessness,
- in Head Start/Early Head Start, and/or
- migrants

should also be included in an ISP. However, their eligibility does <u>not</u> extend to siblings or other household members.

ISP=

of "identified" students
total student enrollment ×100

CEP Reimbursement Pattern

Two categories of reimbursement: Free & Paid

Free reimbursement rate = ISP x 1.6

Paid reimbursement rate = $100\% - (ISP \times 1.6)$

"Magic ISP" = 62.5% (62.5% x 1.6 = 100% of meals reimbursed at the free rate)

ISP	x 1.6 Multiplier	% of Meals Reimbursed at "Free" rate	% of Meals Reimbursed at "Paid" Rate
40%	x1.6	64%	36%
45%	x1.6	72%	28%
50%	x1.6	80%	20%
55%	x1.6	88%	12%
60%	x1.6	96%	4%
65%	x1.6	100%	0%

SNAP enrollment is increasing... That means ISPs may be increasing, too.

Conduct direct certification often to ensure every newly eligible child is captured in your schools' ISPs.

Lock in a high (or higher!) ISP in SY20-21 and for the following 3 years.



Why CEP in SY20-21?

CEP will help with...

- Counting and claiming for new and more complex school meals operations
 - Counting meals by fee category may not be necessary
 - May be able to use a clicker or tally to make cafeteria meal service quicker
 - No need to swipe student IDs or use pin pads
 - Lunch in the classroom is easier
- Easier training for non-food service staff (e.g. teachers) who may be involved with serving and counting meals this year
- Student and staff safety at the point of service
 - No need to swipe student IDs or use pin pads
 - Fewer surfaces to touch



Why CEP in SY20-21? (cont'd.)

CEP will help with...

- Decreasing financial stress among students and families due to COVID-19
- Unpaid school meal debt
 - No collecting of fees = no more meal debt!
 - In schools operating standard counting and claiming this year, meal debt will likely be a larger problem than last
 - General fund does not have to bail out school nutrition fund
- Meal service for the next four years! CEP is a 4-year cycle.
- If P-EBT is reauthorized, CEP schools will have an easier job distributing funds.




Grouping

The 40% ISP threshold may be met by:

- an individual school or
- a group of schools within the district.

Grouping can maximize your federal reimbursement.
