

## Summary of COVID-19 Child Nutrition Program Response Nationwide Waivers & Memos

This resource briefly describes all nationwide waivers and guidance memoranda released by the USDA in response to the coronavirus. Due to the number of extensions, this resource begins with waivers listed by expiration date and then all guidance memoranda by topic and date; the waiver or memo name links to description of the latest version. Next, the table lists waivers and memoranda in order of number and release date. The waiver or memo number in the table links to the USDA landing page for the waiver.

These waivers do **not** apply to all operators automatically -- state agencies must opt in and provide information to operators before operators can implement the waiver. - **CACFP:** Child and Adult Care Food Program
- **CEP:** Community Eligibility Provision
- **Community Eligibility Provision:** A school meals reimbursement option available to schools in which a minimum percentage of students qualify for other means-tested benefit programs like SNAP; in exchange, the school offers meals at no charge to all students
- **FFCRA:** Families First Coronavirus Response Act
- **Families First Coronavirus Response Act:** a COVID-19 relief bill passed by Congress in March that gave the USDA nationwide waiver authority
- **FFVP:** Fresh Fruit and Vegetable Program
- **FNS:** Food and Nutrition Service (a division of the USDA)
- **FSMC:** Food Service Management Company
- **ISP:** Identified Student Percentage
- **LEA:** Local Education Agency (typically a school district)
- **NSLP:** National School Lunch Program
- **PPE:** Personal protective equipment, which includes items like face masks
- **Program Operator:** Includes SFAs, public and private non-profit sponsoring organizations, and independent organizations that work directly with their state agency to run one or more of the child nutrition programs
- **RCCI:** Residential Child Care Institution
- **Residential Child Care Institution:** Includes locations like orphanages, group homes, and other shelters that provide residential care for children; meets the definition of a school in the NSLP regulations
- **SBP:** School Breakfast Program
- **SDA:** State Distributing Agency
- **State Distributing Agency:** The state government agency that oversees USDA Foods
- **SFA:** School Food Authority
- **School Food Authority:** The governing body responsible for operating school meal programs at one or more schools within one or more school districts
- **SFSP:** Summer Food Service Program
- **SMP:** Special Milk Program
- **SNAP:** Supplemental Nutrition Assistance Program
- **SSO:** NSLP Seamless Summer Option
- **SY:** School Year
